# Division of Professional Practices Workload Report

---

---

## Introduction

Updates on the Commission's Division of Professional Practices (DPP) workload are presented to the Commission to provide insight into the scope and level of work in educator discipline. This report covers the period of June through August 2024.

## Background

The Commission's dashboards report on six key measurements in line-graph form, showing both current year numbers as well as prior year numbers for comparison purposes.

The "Total Cases" are the number of open cases within DPP, including cases in the Intake Unit, before the Committee of Credentials (Committee), pending before the Commission, and pending an administrative hearing. At the end of August, the caseload was at 3,572.

"Cases Opened" are new cases opened during the month, from all sources, including criminal arrest notices, district reports, affidavits, and educators who self-report misconduct. In August, DPP opened 601 cases.

The "Initial Review" and "Formal Review" charts reflect the number of cases reviewed by the Committee at its normal three-day meeting in August. This two-step review process is required by statute. There were 73 Initial Review cases prepared in August. This number will fluctuate over the next several months during a cross-training effort, in which new staff are trained.







"Cases Closed" is the number of matters closed by Commission action, Committee action or closed by staff where the Commission has given formal delegation of authority (i.e., single alcohol offenses that do not involve schools, minors, or publicity). In August, 565 cases were closed.

"AG Cases" refers to cases in which an educator requests an administrative hearing to challenge the recommendation for discipline made by the Committee. An administrative hearing is an evidentiary proceeding where an administrative law judge hears and rules on the evidence. The Commission is represented in these hearings by the Office of the Attorney General (AG). The number of cases where the AG is representing the Commission is shown in the last graph. The number of cases currently at the administrative hearing stage is 157.

## Next Steps

The DPP is committed to work that is critical to public service and the Commission's mission. DPP continues to maintain a steady case production, while at the same time ensuring quality case preparation for the Committee.

# Proposed Title 5 Regulation Pertaining to Cost Recovery Fees for Extraordinary Accreditation Activities

---

## Introduction

This agenda item proposes amendments to Title 5 of the California Code of Regulations section 80692 pertaining to cost recovery fees for extraordinary accreditation activities and eliminates outdated language. The item includes edits to the original language of the regulations as well as some minor edits for clarity and formatting of the text for purposes of review by the Office of Administrative Law.

## Authority and Reference

Education Code (EC) section 44225 authorizes the Commission to adopt the proposed regulation amendments. The proposed regulations implement, interpret, and make specific EC section 44374.5 pertaining to fees related to extraordinary accreditation activities.

## Background

The Commission adopted regulations for the authorization and credential requirements for the PK-3 Early Childhood Education (ECE) Specialist Instruction Credential at its August 2022 meeting and adopted the program standards and teaching performance expectations for this credential at its October 2022 meeting. At its December 2022 meeting, the Commission adopted the full set of regulations for the credential with minor revisions and directed staff to move forward with the rulemaking process. The final regulations were approved by the Office of Administrative Law and the regulations became effective as of April 1, 2024.

Concurrently, on December 8, 2022, the Commission adopted amendments to Cost Recovery for Program Approval and Accreditation regulations, sections 80692(a)(2)(A), 80692(a)(2)(B), and 80692(a)(2)(C), 80692(a)(2)(D) and 80692(a)(2)(E), to replace the number of educator preparation program standards as the basis for each fee category with lists of preparation programs included in each fee category. The final revisions and amendments to Title 5 of the California Code of Regulations (CCR) related to Cost Recovery were approved by the Office of Administrative Law and filed with the Secretary of State on June 5, 2024. This regulatory action became effective as of October 1, 2024.

## Summary of Proposed Regulation

The PK-3 ECE Specialist Instruction Credential was approved while the Cost Recovery regulations were still being reviewed by OAL. Since the Cost Recovery regulations were subsequently approved, it is now necessary to update them to reflect the approval of the PK-3 ECE Specialist Instruction Credential. This rulemaking action proposes corrections to the adopted language in sections 80692 of Title 5 of the California Code of Regulations (CCR) related to Cost Recovery fees, specifically adding the PK-3 ECE Specialist Instruction Credential

to Section 80692(a)(1)(B), amending language in Section 80692(a)(1)(C), and deleting text in 80692(a)(1)(C)(7) since it is a duplication of text found in 80692(a)(1)(D)(2). Text proposed to be amended is shown underlined for additions and shown as ~~strike-out~~ for deletions.

### **Staff Recommendation**

Staff recommends that the Commission adopt the proposed amendments into regulations as shown in [Appendix A](#) and authorize staff to move forward with the rulemaking process.

### **Next Steps**

If approved by the Commission, staff will begin the 45-day public comment period, and, if no comments are received during that period, will submit the proposed updated regulations to the Office of Administrative Law.

(E) Initial Program Review: A flat fee of \$500 shall be assessed for each multiple subject, single subject, PK-3 Early Childhood Education Specialist Instruction Credential and Education Specialist internship program.

(F) A professional preparation program that provides a number of Board of Institutional Review members that is equal to or greater than two times the number of their program documents submitted for initial program review annually and that assume all travel costs related to the review of the program documents submitted for initial review shall be exempt from payment of the fees associated with subsection (a)(1).

(2) Fees for the following activities in excess of the regularly scheduled accreditation activities shall be submitted to the Commission in the year that the extraordinary activities are performed:

(A) Focused site visit: \$1,000 for each individual attending the focused site visit.

(B) Late reviews: \$500 per submission.

(C) Stipulations:

1. Site revisit: \$1,000 per individual attending the site revisit.

2. Review of a report due to stipulations that does not require a site revisit as detailed in the *Accreditation Handbook*, Chapter Nine, Activities during the Seventh Year of the Accreditation Cycle (Rev. 2012), hereby incorporated by reference: \$500 flat fee.

3. Review of a report associated with a site revisit as detailed in the *Accreditation Handbook*, Chapter Nine, Activities during the Seventh Year of the Accreditation Cycle (Rev. 2012): \$1,000 flat fee.

# Proposed Precondition Language for Child Welfare and Attendance Added Authorization Programs

---

---

## Introduction

This agenda item proposes to add a precondition for Child Welfare and Attendance Added Authorization (CWA) programs. This precondition reflects the language of Title 5 California Code of Regulations Section 80049(a) and would ensure that programs verify that candidates are eligible to receive the authorization.

## Background

Candidates seeking a CWA Added Authorization may earn this authorization either after they have earned a Pupil Personnel Services (PPS) credential in School Counseling, School Social Work, or School Psychology, or concurrently with one of these credentials. The PPS program standards and performance expectations adopted by the Commission in 2019 embedded the content for the CWA Added Authorization into the existing PPS programs allowing all interested candidates in programs approved by the Commission to offer the CWA Added Authorization to earn this additional authorization concurrently or after receiving their PPS credential upon completion of 150 fieldwork hours in child welfare and attendance activities.

However, candidates who completed a PPS credential program under a prior set of program standards who now want to earn the CWA Added Authorization would not necessarily have had the content required for the CWA Added Authorization. There was a need, therefore, for a set of CWA Added Authorization standards to clarify what content these types of candidates would need to complete in order to earn the authorization. Additionally, with the passage of [Senate Bill 223](#) (Chap. 175, Stats. 2024) local education agencies are now authorized to offer the CWA Added Authorization, so a stand-alone set of program standards is necessary for use by these institutions as well. To address these needs, the Commission adopted Child Welfare and Attendance Added Authorization standards at the [August 2024 Commission meeting](#).

The proposed precondition will ensure program sponsors understand the requirement in Title 5 section 80049(a) that the CWA Added Authorization must be added to PPS School Counseling, School Psychology, or School Social Work credential and, therefore, programs must ensure that candidates for the authorization hold one of these base PPS credentials or be earning the CWA Added authorization concurrently with their base credential. Creating this precondition will greatly reduce the possibility that individuals might take coursework toward a CWA credential for which they may not be eligible.

The relevant Title 5 regulation is indicated below:

*Section 80049 (a)*

*Individuals seeking the School Child Welfare and Attendance area must also hold or be issued concurrently an authorization in School Counseling, School Social Work, or School Psychology.*

The proposed precondition is as follows:

***Prerequisite Credential*** [Title 5 CCR §80049 (a)] *An institution operating a program for the Child Welfare and Attendance Added Authorization must verify, prior to recommending a candidate for the authorization, that the candidate holds a prerequisite credential or is recommended for a prerequisite credential simultaneously. Individuals seeking the Child Welfare and Attendance added authorization must hold or be issued concurrently an authorization in School Counseling, School Social Work, or School Psychology*

### **Staff Recommendation**

Staff recommends that the Commission adopt the proposed precondition to ensure that programs are verifying that candidates are eligible (hold a base PPS credential or be earning it simultaneously to their CWA Added Authorization) to be granted the Child Welfare and Attendance Added Authorization.

### **Next Steps**

If approved by the Commission, staff will build this precondition into the precondition review process in years 1 and 4 for all Commission approved CWA programs.

## Report on Number of Examination Fee Waivers by Type for Fiscal Year 2023-24

### Introduction

This report includes information on the numbers of examinations taken and performance assessments submitted for scoring as well as the number of exams and performance assessments registered for but not yet taken or submitted during the 2023-24 fiscal year (July 1, 2023, to June 30, 2024). Table 1 provides the funds expended for examinations taken and assessments submitted as well as the funds encumbered for those who registered but have not yet taken their examinations or submitted their assessments. Those who registered at any time during fiscal year 2022-23 have one year from the time of registration to take an exam or submit a performance assessment. Table 2 provides a monthly breakdown of examinations taken and assessments submitted for scoring.

# Literacy Performance Assessment - Field Test Participant Waiver Requests

---

## Introduction

This consent item presents requests that the Commission waive the Reading Instruction Competence Assessment (RICA) requirement and, if applicable, CalTPA Cycle 2, for candidates who successfully complete the Literacy Performance Assessment (LPA) and meet the passing standard for the LPA field test set by the Commission. This item recommends that the Commission approve the requested waiver for selected institutions for candidates that meet the adopted passing standard of 14 points from [Item 5D](#) at the August 2024 Commission meeting.

## Background on the Teaching Performance Assessment Requirement

Current law requires individuals seeking a teaching credential in California to fulfill several requirements. PK-3 Early Childhood Education (ECE) Specialist credential candidates, Multiple Subject (MS), Education Specialist (EdSp) - Mild to Moderate Support Needs (MMSN) and Extensive Support Needs (ESN) credential candidates must pass the Reading Instruction Competence Assessment (RICA) and a Teaching Performance Assessment (TPA). Education Specialist (EdSp) Early Childhood Special Education (ECSE), Deaf and Hard of Hearing (DHH), and Visual Impairments (VI) credential candidates must pass the RICA. PK-3 ECE, MS, and EdSp candidates are also required to successfully complete Teaching Performance Expectations (TPE) aligned coursework and clinical practice requirements.

Following the passage of [SB 488 \(Chap. 678, Stats. 2021\)](#), Education Code (EC) [§44283](#) and [§44283.2](#) were amended and EC [§44259](#) (b) (4) (A) and (B) were added to require the Commission to complete a series of actions related to literacy instruction. For more information regarding SB 488 requirements, see [Item 4E: Report to the Legislature on the Implementation of Senate Bill 488 Teacher Credentialing – Reading Instruction](#) and [Item 4B: Literacy Performance Assessment Pilot Study-Participant Waiver Requests](#) from August 2023.

Pursuant to SB 488, all approved Teaching Performance Assessments (TPAs) must include a literacy component that meets the requirement of SB 488 by July 1, 2025, as a replacement for the RICA requirement. The TPA provides the opportunity to measure Teaching Performance Expectation (TPE) Domain 1-7 elements observable through performance assessment that teacher candidates must be able to demonstrate prior to being recommended for a preliminary credential.

In August 2024, Commission staff presented a [detailed agenda item](#) describing the development of the LPA and of the results of the LPA pilot study. Consistent with statute under EC [§44225\(m\)](#), [a second item](#) that requested that the Commission approve waivers for all field test participant candidates who completed the LPA and met the Commission's adopted passing standard for the

field test. The expanded field test will assure that the LPA is ready for full implementation in fall 2025 as required by statute.

**Criteria for the Selection of Institutions to Participate in the Field Test**

The field test of the LPA will provide an opportunity to collect data about the teaching performance of 250-300 candidates across a sample of institutions and program types that reflect the diversity of program sizes, candidates served, institutional affiliations, pathways, and service areas in California. The field test sought to include candidates at institutions using all three models: the CalTPA, edTPA, and FAST.

The Field test Plan for the LPA identifies the following credential types and target number of responses needed for the field test. In addition, the table presents sample targets for low incidence programs: Deaf and Hard of Hearing (DHH), Visual Impairments (VI), and Early Childhood Special Education (ECSE) - who currently are not required to pass a TPA but are required to pass RICA.

Institutions in Tables 3-9 meet the following participation criteria:

1. The institution is in good standing with the Commission, and its preliminary PK-3 ECE, Multiple Subject, and Education Specialist (MMSN and ESN) teacher preparation programs meet all standards.

2. The preliminary PK-3 ECE, Multiple Subject, and Education Specialist (MMSN and ESN) teacher preparation program has been reviewed by literacy experts and determined to be teaching TPE Domain 7 content.
3. The preliminary Education Specialist low incidence (DHH, VI, and ECSE) teacher preparation program has been reviewed by literacy experts and determined to be teaching TPE Domain 7 content.
4. The institution agrees to fully participate in the field test, which requires:
  - a. Working with Evaluation Systems (ES) and Commission staff to select a diverse group of candidates by December 2024 to field test the LPA;
  - b. Providing the expected level of support for field test participants defined in program standard 5 with an additional focus on TPE Domain 7 elements measured by the LPA;
  - c. Ensuring that all field test participants have a fair and equitable opportunity to complete the LPA and submit scoreable evidence to ES by April 2025; and
  - d. Providing field test participants who do not meet the expected performance level on the LPA with remedial support and the opportunity to either:
    - a. Resubmit their LPA field test submission no later than July 31<sup>st</sup> for rescoring
    - b. Take and pass the operational LPA
5. The institution contributes to an appropriately diverse pool of field test participants that includes different types of programs (PK-3 ECE, MS, MMSN, ESN, DHH, VI, and ECSE) and program pathways (Intern, ITEP [integrated undergraduate program], Residency, Traditional 5<sup>th</sup> Year), candidates, geographic regions, and demographics.

Once programs met the above criteria, literacy experts worked with Commission staff to review required program materials. Materials included survey responses, literacy and/or literacy-related course syllabi, RICA and TPA data, and accreditation and Dyslexia grant status. Once the literacy experts determined that programs met the criteria, Commission staff and Evaluation Systems (ES), worked to determine a purposeful sample that represents type of credential programs, program pathways, candidates, and geographic regions.

Upon the Commission’s approval of these candidates from the selected programs, Commission staff will communicate with programs and begin providing online support to prepare faculty and cooperating teachers for the administration of the LPA field test beginning in January 2025.

**Staff Recommendation**

Staff recommends that the Commission:

1. Approve candidate waiver requests from selected institutions to waive the RICA requirement for those who meet the approved passing standard of 14 points for the LPA field test.
2. Approve candidate waiver requests from selected institutions to waive the CalTPA Literacy Cycle 2 requirement for those whose institutions using the CalTPA model and who meet the approved passing standard of 14 points for the LPA field test.

**Next Steps**

If the Commission approves the waiver requests for candidates participating in the LPA field test, then ES and Commission staff will communicate with the institutions and their selected candidates for the field test, conduct an orientation with participating programs, cooperating teachers, and candidates, and initiate the field test in January 2025. If requests come in after the October 2024 Commission meeting, these waiver requests will be placed on the December 2024 Consent Calendar.

## Introduction

This consent item presents criteria for the two institutions identified for the CalTPA PK-3 Math Cycle field test and requests that the Commission waive the current CalTPA Cycle 1 requirement, for candidates who successfully complete the CalTPA PK-3 Math Cycle Performance Assessment and meet the field test expected performance level set by the Commission. This item recommends that the Commission approve the requested waivers for the PK-3 candidates that meet the adopted passing standard of 14 points from [Item 5D](#) at the August 2024 Commission meeting.

## Background on the Teaching Performance Assessment Requirement

[Education Code §44320.2](#) requires all candidates for a Preliminary Multiple or Single Subject Teaching Credential to pass an assessment of their teaching performance as part of the requirements for earning a preliminary teaching credential. Currently there are three Commission-approved Teaching Performance Assessment (TPA) models: CalTPA, edTPA, and FAST for Multiple Subject candidates. Commission staff are developing a PK-3 version of the CalTPA based on the newly adopted PK-3 Early Childhood Education (ECE) teaching performance expectations (TPEs).

The Commission's CalTPA model has been approved for use in California since 2008. Cycle 1: Learning about Students and Planning Instruction is currently being revised and has been retitled to CalTPA PK-3 Math Cycle Performance Assessment: Learning about Children and Planning a Math Activity. New math cycle assessment tasks and scoring rubrics have been developed to assess the PK-3 ECE Teaching Performance Expectations (Domains 1 through 8), specifically the new TPE Domain 8: Effective Mathematics Instruction in a PK-3 setting, with input from the PK-3 Math Cycle Performance Assessment Workgroup found in [Appendix A](#).

The field test of the CalTPA Math Cycle will provide an opportunity to collect data about the teaching performance of 17 candidates for two recently approved PK-3 ECE programs. Riverside County Office of Education (RCOE) is a local education agency (LEA) Intern program while Vanguard University is a 5th year traditional student teaching pathway.

Institutions in Table 1 meet the following participation criteria:

1. The institution is in good standing with the Commission and has been approved to offer a preliminary PK-3 teacher preparation program.
2. The institution agrees to fully participate in the CalTPA PK-3 Math Cycle field test, which requires:

- a. Working with Evaluation Systems (ES) and Commission staff to select a diverse group of candidates by December 2024 to field test the CalTPA PK-3 Math Cycle;
- b. Providing the expected level of support for field test participants defined in program standard 6 with the additional focus on TPE Domain 8 elements measured by the CalTPA PK-3 Math Cycle;
- c. Ensuring that all field test participants have a fair and equitable opportunity to complete the CalTPA PK-3 Math Cycle and submit scoreable evidence to ES by December 2024; and
- d. Providing field test participants who do not meet the expected performance level on the CalTPA PK-3 Math Cycle with remedial support and the opportunity to resubmit the Math Cycle in January 2025.

Once waivers are approved for the two programs’ candidates, Commission staff will communicate to programs and begin providing online support to prepare faculty and cooperating teachers for the fall administration of the CalTPA PK-3 Math Cycle field test.

**Institutions Requesting Candidate Waivers**

The following table provides the information for programs who have submitted waiver requests on behalf of candidates as of September 30 at 12:00 p.m. Requests received after September 30 at 12:00 p.m. will be presented at the December Commission meeting. Program’s waiver requests on behalf of the candidates are found in [Appendix B](#).

**Staff Recommendation**

Staff recommends that the Commission approve candidate waiver requests from identified institutions to waive the current CalTPA Cycle 1 in Math requirement for those who meet the approved passing standard of 14 points for the CalTPA PK-3 Math Cycle field test.

**Next Steps**

If the Commission approves the waiver requests for candidates participating in the CalTPA PK-3 Math Cycle field test, then staff and Evaluation Systems will work with the institutions and their selected candidates for the field test, continue orientation with participating programs and candidates, and initiate the field test. If candidate waiver requests come in after the October 2024 Commission meeting, they will be placed on the Commission’s December 2024 Consent Calendar.

# Proposed Regulatory Amendments Pertaining to PK-3 Early Childhood Education Specialist Instruction Teaching Performance Expectations

---

---

## **Introduction**

This consent item presents information related to the proposed amendments to Title 5 of the California Code of Regulations (CCR), §80067.3(a) to implement a new requirement pertaining to the performance assessment requirement.

## **Background**

The Commission adopted regulations for the PK-3 Early Childhood Education Specialist Instruction Credential, which became effective on April 1, 2024. At the time the regulations were adopted, a Teaching Performance Assessment (TPA) specific to the preliminary PK-3 Early Childhood Education Specialist Instruction Credential (PK-3) was still under development. The regulations adopted by the Commission permitted PK-3 preparation programs to use the Multiple Subjects TPA until the PK-3 TPA was ready. The PK-3 TPA is currently being field tested and will be fully operational by July 1, 2025. This item requests Commissioners approve a minor change to the regulations that would remove the temporary Multiple Subjects TPA option and replace it with the ongoing PK-3 TPA requirement beginning on July 1, 2025.

## **Staff Recommendation**

Staff recommends approval of the final proposed amendments to Title 5 of the CCR to require that educators complete and pass an approved teaching performance assessment for the PK-3 Early Childhood Education Specialist Instruction Credential. The new PK-3 version is modeled on the current multiple subject's version but is customized to the PK-3 Teaching Performance Expectations. Therefore, it is appropriate for preparation programs and candidates to use.

#### **§ 80067.3. PK-3 Early Childhood Education Specialist Instruction Teaching Performance Expectations (TPEs).**

(a) Preliminary Credential Requirements: The minimum requirements for the preliminary PK-3 Early Childhood Education Specialist Instruction Credential for applicants shall include:

- (1) Possession of a bachelor's or higher degree from a regionally-accredited institution of higher education.
- (2) Completion of a professional preparation program pursuant to Education Code sections 44225(h) and 44370 and in accordance with sections 80067.1 and 80067.2 that:
  - (A) meets the PK-3 ECE Program Standards and Teaching Performance Expectations outlined in sections 80067.1 and 80067.2, including literacy standards and Teaching Performance Expectations outlined in sections 80067.2(g) through (o) and adopted pursuant to Senate Bill 488, Chapter 678, Statutes of 2021,
  - (B) is approved by the Committee on Accreditation based upon the standards and expectations outlined in sections 80067.1 and 80067.2 for the PK-3 Early Childhood Education Specialist Instruction Credential, and
  - (C) includes preparation to serve English learners and a 600-hour clinical practice experience with a minimum of 200 hours in a preschool (PK) and/or transitional kindergarten (TK) setting and a minimum of 200 hours in a kindergarten through third grade (K-3) setting.
- (3) For candidates first enrolled in a PK-3 Early Childhood Education Specialist program prior to July 1, 2025, p~~Passage of a commission approved teaching performance assessment for multiple subjects in a PK-3 setting, or passage of a commission approved teaching performance assessment for ~~early childhood education~~ the PK-3 Early Childhood Education Specialist Instruction Credential.~~ For candidates first enrolled in a PK-3 Early Childhood Education Specialist program on or after July 1, 2025, passage of a commission approved teaching performance assessment for the PK-3 Early Childhood Education Specialist Instruction. Commission approval of a teaching performance assessment will be in accordance with Education Code sections 44225(i) and (j) based upon the commission's mission to ensure integrity, relevance, and high quality in the preparation and certification of the educators who serve all of California's diverse students.
- (4) Completion of the subject matter requirement by one of the following:
  - (A) Possession of a bachelor's or higher degree from a regionally accredited institution of higher education with a degree major in the field of child development, child and adolescent development, human development, early childhood education, child and family studies, early childhood studies, family science, human development and family science, or child, adolescent, and family studies.

(B) Completion of 24 semester units or the equivalent quarter units of non-remedial, degree-applicable coursework at a regionally accredited institution of higher education in early childhood education and/or child development.

(5) Passage of either the Reading Instruction Competence Assessment (RICA), or a literacy performance assessment approved by the Commission for the PK-3 Early Childhood Education (ECE) Specialist Credential that is aligned with the requirements outlined in Education Code section 44320.3.

(b) Clear Credential Requirements: The minimum requirements for the clear PK-3 Early Childhood Education Specialist Instruction Credential shall include:

(1) Possession of a preliminary PK-3 Early Childhood Education Specialist Instruction Credential issued based on the requirements outlined in section (a).

(2) One of the following:

(A) Enrollment in and successful completion of a commission approved Teacher Induction program pursuant to Education Code section 44279.1, or

(B) Possession of a valid National Board Early Childhood/Generalist certificate. A qualified applicant holding a valid clear Multiple Subject, Single Subject, or Education Specialist Teaching Credential who has previously completed a commission approved Teacher Induction program shall, upon completion of a preliminary PK-3 Early Childhood Education Specialist Instruction Credential program, be granted a clear PK-3 Early Childhood Education Specialist Instruction Credential without first being required to hold a preliminary PK-3 Early Childhood Education Specialist Instruction Credential or complete an additional induction experience. Such applicants may apply directly to the commission for the clear credential in the same manner as outlined in subsection (h)(2).

(c) Professional Preparation Program Models: For the purposes of this section, professional preparation programs referenced in subsection (a)(2) may include any of the following program models offered by a commission accredited program sponsor pursuant to Education Code sections 44225(h) and 44374 and in accordance with sections 80067.1 and 80067.2:

(1) Integrated undergraduate teacher preparation program, approved by the commission, which may be offered by a regionally-accredited institution of higher education.

(2) Combined community college and baccalaureate or post-baccalaureate teacher preparation program, approved by the commission, which may be offered by a regionally-accredited institution of higher education.

(3) Post-baccalaureate teacher preparation program, approved by the commission, which may be offered by a regionally-accredited institution of higher education.

(4) Teacher residency program, approved by the commission, which may be offered by a regionally-accredited institution of higher education in partnership with one or more LEAs.

(5) Intern teacher preparation program, approved by the commission, which may be offered by a California public school, school district or county office of education, or by a regionally-accredited college or university, that shall include the additional requirements outlined in subsection (A) below. Intern programs are a partnership between the commission accredited program sponsor and the California employing agency that elects to employ an individual as the teacher of record on the basis of an intern credential. The requirements outlined in subsections (A)(i), (A)(ii), and (A)(iii)

below must be met prior to the recommendation for and issuance of an intern teaching credential by the accredited program sponsor.

(A) Support and Supervision.

(i) Prior to an intern teacher assuming daily teaching responsibilities, a signed Memorandum of Understanding must be in place between the commission accredited program sponsor and the California employing agency detailing the support and supervision that will be provided.

(ii) The commission accredited program sponsor in cooperation with the California employing agency shall counsel the intern candidate and develop a plan to complete the requirements to earn a credential in the content or specialty area(s) of the intern credential. The commission accredited program sponsor, employing agency, and the intern teacher shall concur on the program planned.

(iii) Prior to an intern teacher assuming daily teaching responsibilities, the California employing agency must identify for the intern teacher a mentor who possesses a valid, corresponding life or clear teaching credential and a minimum of three years of successful teaching experience.

(iv) A minimum of 144 hours of support/mentoring and supervision shall be provided to each intern teacher per school year to coach, model, and demonstrate within the classroom, and to assist with course planning and problem-solving regarding students, curriculum, and effective teaching methodologies. The minimum support/mentoring and supervision provided to an intern teacher who assumes daily teaching responsibilities after the beginning of a school year shall be equal to 4 hours times the number of instructional weeks remaining in the school year. A minimum of two hours of support/mentoring and supervision shall be provided to an intern teacher every five instructional days.

(v) The following additional support/mentoring and supervision shall be provided to an intern teacher who enters the program without a valid English learner authorization listed on a previously issued multiple subject, single subject, or education specialist instruction teaching credential; a valid English learner authorization or CLAD Certificate issued pursuant to section 80015; or a valid bilingual authorization issued pursuant to section 80015.1:

a. The commission accredited program sponsor shall provide 45 hours of support/mentoring and supervision per school year, including in-classroom coaching, specific to the needs of English learners. The minimum support/mentoring and supervision provided to an intern teacher who assumes daily teaching responsibilities after the beginning of a school year shall be equal to five hours times the number of months remaining in the school year. The support/mentoring and supervision should be distributed in a manner that sufficiently supports the intern teacher's development of knowledge and skills in the instruction of English learners.

b. The California employing agency shall identify an individual who will be immediately available to assist the intern teacher with planning lessons that are appropriately designed and differentiated for English learners, for assessing language needs and progress, and for support of language accessible instruction through in-classroom modeling and coaching as needed. The identified individual may be the same mentor assigned pursuant to (5)(A)(iii) provided the individual possesses an English learner authorization and will be immediately available to assist the intern teacher.

c. An individual who passes the CTEL examinations specified in section 80015.3(a) prior or subsequent to the issuance of the intern credential may be exempted from the provisions of a and b above.

(d) Professional Preparation Program Equivalency: Commission approved professional preparation programs shall recognize and grant equivalency for prior experience as follows:

(1) PK-3 Early Childhood Education Specialist Instruction Credential candidates that meet both the requirements outlined in subsections (A) and (B) below shall be granted equivalence for at least 200 hours of the required clinical practice experience in a PK or TK setting and may be granted equivalence for an additional 200 total hours of the required clinical practice experience in a PK or TK setting within the program of professional preparation. Such candidates must complete all other program requirements, including a clinical practice experience of at least 200 hours in a K-3 setting.

(A) Either 1) hold a valid Child Development Permit at the Teacher level or higher, or 2) verify employment as a lead teacher in a Head Start program, or 3) verify employment as a lead teacher in a childcare and development center serving preschool-aged children.

(B) Verify six (6) years or more of satisfactory, full-time teaching experience as a lead teacher in a public or private center-based childcare and development program serving preschool-aged children that is either a license-exempt childcare and development center pursuant to California Health and Safety Code section 1596.792(o) or holds a license as defined in section 101152(l)(1), Article 1, Chapter 1, Division 12, of Title 22.

(i) Satisfactory teaching experience shall be verified by the public or private center-based childcare and development center. Verification shall include a statement by the employer confirming that the teacher's performance was rated satisfactory or better in the following areas:

- The use of developmentally appropriate teaching strategies for preschool-aged children.
- The ability to establish and maintain developmentally appropriate standards and expectations for student behavior.
- A demonstration of deep knowledge of the early literacy, early mathematics, and other preschool subjects, and the use of developmentally appropriate teaching and learning approaches that engage students and promote student understanding.

- An ability to plan and implement a sequence of appropriate learning activities, both teacher and child initiated.
- An ability to evaluate and assess student learning outcomes.
- An ability to communicate effectively with young children and their families/guardians.

(ii) Full-time experience shall be defined as classroom-based teaching for at least three hours per day, for at least 75% of the school year. Part time experience, or experience serving as anything other than a lead teacher, shall not be acceptable.

(iii) Lead teacher means an adult who has direct responsibility for the care and development of children from birth to 5 years of age in a center-based early childhood care setting, and serves in a teaching capacity with 3 or 4 year olds.

(2) Candidates for the PK-3 ECE Specialist Instruction Credential who have completed a practicum course at a regionally accredited institution of higher education, including a community college, shall be granted clinical practice equivalency for these hours commensurate with the number of hours served in the practicum course, up to a maximum of 200 hours, provided that all of the following conditions are met:

(A) The practicum course is credit bearing and degree applicable towards a Teacher Level or higher level Child Development Permit or a degree in early childhood education, child development, child and adolescent development, early childhood studies, or human development.

(B) The practicum hours completed were in a preschool or early childhood setting serving 3-4 year old children and included clinical practice experience that was supervised at minimum by a trained faculty member/instructor with expertise in Early Childhood and Child Development pedagogy who provided observation and feedback to the candidate.

(C) The candidate earned a C or better on the practicum course. Courses earned with a "Pass," or another designation deemed by the institution of higher education to be equivalent to a grade of "C" or higher are also acceptable.

(D) The candidate provides to the Commission-approved PK-3 ECE Specialist Instruction program verification of the hours served through transcripts and other documentation as determined by the Commission-approved program.

(3) Candidates who have completed both a verified work experience as outlined in paragraph (d)(1) above and a qualified practicum experience as outlined in paragraph (d)(2) above may be granted a maximum of 400 hours total toward the clinical practice requirement and shall complete the remaining 200 hours of clinical practice in the teacher preparation program.

(e) Multiple Subject Teaching Credential Holder Equivalencies: PK-3 Early Childhood Education Specialist Instruction Credential candidates that also hold a valid Multiple Subject Teaching Credential with an English learner authorization who have met statutory requirements for the Multiple Subject Teaching Credential are exempt from the professional preparation program requirements outlined in subsection (a)(2) and (a)(3) above. Such candidates may apply directly to the commission by submitting all of the following, and will be issued a PK-3 Early Childhood Education Specialist Instruction Credential with a term of preliminary or clear based upon and in alignment with the term of their valid Multiple Subject Teaching Credential:

(1) Official transcripts verifying completion of the subject matter requirement outlined in subsection (a)(4), and

(2) A competed application as defined in section 80002; the processing fee as specified in section 80487(a)(1); and fingerprint clearance as specified in section 80442.

(f) Authorizations and Scope: The authorization for the PK-3 Early Childhood Education Specialist Instruction Credential shall be as follows:

(1) The authorization for teaching services shall be issued with the following statement: "This credential authorizes the holder to teach all subjects in a self-contained general education classroom setting and, as a self-contained classroom teacher, to team teach or to regroup students across classrooms, in preschool through grade three."

(2) The authorization for English learner services shall be issued with the following statement: "The following instructional services may be provided to English learners in the settings and content area(s) specified on this document: (1) English language development defined as instruction designed specifically for limited-English-proficient students to develop their listening, speaking, reading, and writing skills in English; and (2) specially designed content instruction delivered in English defined as instruction in a subject area, delivered in English, that is specially designed to meet the needs of limited-English-proficient students. This English learner authorization also covers classes taught on the basis of other valid, non-emergency credentials or permits held within the settings or content/specialty area(s) listed at the grade or age levels authorized."

(3) In addition to the teaching authorizations provided in subsections (f)(1) and (f)(2) above, an intern credential shall be issued with the following statement: "This individual has completed the intern preservice preparation, which included specific instruction on the teaching of English learners and is participating in a Commission approved intern preparation program. The individual must be supported by both the commission accredited program and the employer in the area(s) listed and in their work with English learners and must make satisfactory progress toward program completion for the duration of the intern credential."

(4) An intern credential shall also be restricted to service with the California employing agency identified by the commission accredited program sponsor.

(g) Credential Validity: Period of validity for PK-3 Early Childhood Education Specialist Instruction Credential shall be as follows:

(1) An intern credential issued pursuant to this section shall be initially issued for two years.

(2) A preliminary credential issued pursuant to this section shall be initially issued for five years.

(3) A clear credential issued pursuant to this section shall be valid for five years.

(h) Submission of Applications: Issuance of the PK-3 Early Childhood Education Specialist Instruction Credential shall require the following:

(1) For the preliminary credential candidate that has met all requirements outlined in section (a), submission by the program sponsor of a formal online recommendation including submission of an application as defined in section 80002; the processing fee as specified in section 80487(a)(1); and fingerprint clearance as specified in section 80442.

(2) For the clear credential candidate that has met the requirement in section (b)(2)(i), submission by the program sponsor of a formal online recommendation including

submission of an application as defined in section 80002; the processing fee as specified in section 80487(a)(1); and fingerprint clearance as specified in section 80442.

(3) For the clear credential candidate that has met the requirement in section (b)(2)(ii), the candidate may apply directly to the commission by submitting an application as defined in section 80002; the processing fee as specified in section 80487(a)(1); and fingerprint clearance as specified in section 80442.

(4) For the intern program candidate that is enrolled in the program and has met the provisions of section (a) and subsection(c)(5)(A), submission by the program sponsor of a formal online recommendation including submission of an application as defined in section 80002; the processing fee as specified in section 80487(a)(1); and fingerprint clearance as specified in section 80442.
