### ***Thursday, September 19, 2024***

Executive Director Mary Vixie Sandy started the September 19-20, 2024 Workgroup to Review the Design and Implementation of Teaching Performance Assessments (RDI-TPA) meeting at 1:06 a.m. Roll call was taken and the Pledge of Allegiance was recited.

### **1A: Election of Chair Pro-Tempore**

**Cathy Yun**, submitted a written comment which voiced the importance of the TPA and suggested preparation programs be provided with more guidance and support on how to design their programs to integrate coursework and clinical experiences and help candidates develop an inquiry-based habit of mind.

Mary Vixie Sandy, Executive Director, presented this item which provided information regarding the election of Co-Chairs of the RDI-TPA Workgroup.
