Proposed Elimination of a Precondition for Preliminary Multiple Subject and Single Subject Credential Programs

Introduction

This agenda item proposes the elimination of a precondition for Multiple Subject and Single Subject preparation programs that is no longer aligned with the Education Code it references.

Background

At the request of the California State University (CSU), Precondition 4 for the Preliminary Multiple Subject and Single Subject credential programs was reviewed to determine its current relevance and standing as a precondition. Staff have determined that Precondition 4 for the Preliminary Multiple Subject and Single Subject credential programs is no longer aligned to the referenced Education Code and recommends it be eliminated. The relevant Precondition and Education Code language are as follows:

Precondition (4) Undergraduate Student Enrollment

Undergraduate students of any campus of the California State University or the University of California shall be allowed to enroll in any professional preparation course. Reference: Education Code Section 44320(a).

Education Code Section 44320

(a) Professional preparation, including student teaching, shall be made available in the upper division course offerings at all California public institutions of higher learning, except the California Maritime Academy and the college named in Section 92200.

The relevant Education Code section requires California public institutions of higher learning to make available professional preparation in only the upper division courses, whereas Precondition 4 requires institutions to allow enrollment in any preparation course as an undergraduate.

Elimination of this precondition would be responsive to concerns expressed from the field that, as written, the requirement goes beyond standard admission practices and policies at public institutions. Further, staff argues that this provision in this section of code is more appropriately within the purview of the CSU and UC, rather than the Commission.

Recommendation

Staff proposes the elimination of Preliminary Multiple Subject and Single Subject Precondition (4).

Follow Up on the 2023 Diverse Education Leaders Pipeline Initiative Grant Program

Introduction

This consent item provides additional information on the 2023 Diverse Education Leaders Pipeline Initiative Grant Program to address the Commission's questions from June 2024 regarding the Update on the 2023 Diverse Education Leaders Pipeline Initiative Grant Program.

Background

The California state budget signed by the Governor in September 2023 includes \$10 million from funding appropriated in Senate Bill 141 Section 112 (Chap. 48, Stats. 2023) for the Diverse Education Leaders Pipeline Initiative (DELPI) Grant Program. One-time grant awards of up to \$30,000 per participating administrator candidate was made available to Local Education Agencies (LEAs) interested in securing grant funding to support eligible participants to pursue an administrative services credential. The purpose of the grant program is to train, place, and retain diverse and culturally responsive administrators in transitional kindergarten, kindergarten, and grades 1 to 12, inclusive, to improve pupil outcomes and meet the needs of California's education workforce. In performing these activities, grant applicants were highly encouraged to partner with an institution of higher education (IHE) or a nonprofit educational service provider, or both, as applicable. This funding shall be available for encumbrance until June 30, 2027.

The Request for Applications (RFA) was released January 12, 2024 and [awards](#) were announced May 13, 2024. Thirty-one applications were received, requesting a total of \$36,030,592.33 in grant funds. Ten LEAs were initially conditionally funded, successfully submitted the requested information, and were fully funded, for a total of \$9,996,669 in grant funds to support 367 administrator candidates.

Following the June 2024 presentation of the *Update on the 2023 Diverse Education Leaders Pipeline Initiative Grant Program*, Commissioners requested additional information regarding the grant award process, including how slots were awarded in the competitive award process, the geographical distribution of applicants, and the grantee consortiums LEAs.

Grantee Selection Process

Applicants for the Diverse Education Leaders Pipeline Initiative Grant Program (DELPI) submitted responses to a [Request for Applications \(RFA\)](#).

Per authorizing statute, when selecting grant recipients, the Commission shall do both of the following:

- (1) Develop criteria for the awarding of competitive grants and an application process, request necessary data from participating local educational agencies, and award grants consistent with this section. Successful applicants shall demonstrate an understanding of

how diverse and culturally competent school leadership affects pupil academic success and social-emotional well-being, family engagement, and the retention of a diverse educator workforce.

(2) Give priority consideration to grant applicants who demonstrate a commitment to increasing diversity in the teaching workforce, have a higher percentage than other applicants of enrolled unduplicated pupils, as defined in Section 42238.02 of the Education Code, and have one or more schools that exhibit one or both of the following characteristics:

(A) A school where 50 percent or more of the enrolled pupils are eligible for free or reduced-price meals.

(B) A school that is located in either a rural location or a densely populated region.

A structured scoring guide was used to evaluate each application’s responses. As part of their response, each applicant was asked to describe and provide data to explain the local need for diverse and culturally responsive administrators and to also describe their capacity to support staff in earning a Preliminary Administrative Services Credential. Table 1 provides a full summary of the selection criteria from the scoring guide.

The applications that received the highest scores as calculated using the selection criteria were recommended to the Executive Director of the Commission on Teacher Credentialing for funding. Because demand for participation across the state exceeded funding for the program, not all administrator candidate slots requested by each successful grant applicant were ultimately authorized. All awarded grantees were funded close to 74% of the total number of candidate slots requested in the grant application.

Applicant Summary

Thirty-one applications were received, and ten grantees were awarded. Table 2 compares the DELPI Grant applicants that were awarded and those that were not awarded. The ten LEAs and the consortium LEAs awarded represent a total of 749,635 enrolled students, while the 21 LEAs and consortium LEAs not awarded represent 1,090,968 enrolled students. All grantees, as compared to the applicants not awarded, have a higher percentage of LEAs across all three priority areas defined by authorizing legislation: at least one LEA where 50 percent or more of the enrolled pupils are eligible for free or reduced-price meals, at least one LEA in a rural location, and at least one LEA located in a densely populated region. The aggregate of the 10 LEAs awarded and the LEA consortiums had a higher total percentage of free or reduced-priced meals (79.52%), as compared to the 21 LEAs not awarded (67.48%).

Using the [2020 California Census regions](#), Table 2 also provides a regional breakdown of the applicant LEAs and consortium LEAs. [Appendix A](#) visually demonstrates the geographic distribution of LEA applicants across the state, awarded and not awarded. Note that geographic distribution was not a priority area defined by authorizing legislation.


