Co-Chair Mandy Redfern convened the December 4-5, 2024 Workgroup to Review the Design and Implementation of Teaching Performance Assessments (RDI-TPA) meeting at 2:00 p.m. Roll call was taken and the Pledge of Allegiance was recited.

### **1A: Approval of the November 2024 RDI-TPA Workgroup Meeting Minutes**

**Reconvene and Roll Call**

Co-Chair Mandy Redfern reconvened the RDI-TPA workgroup meeting at 8:36 a.m. and roll call was taken.

**1B: Day 2 General Session**

Mandy Redfern, RDI-TPA Workgroup Co-Chair, welcomed everyone and provided instructions for the day 2 of the RDI-TPA Workgroup meeting.

**3A: Develop Consolidated Recommendations – Focus Area 1**

Workgroup members continued drafting consolidated recommendations for Focus Area 1: *Modifications needed for current teaching performance assessments* in small groups.

**4A: Present and Prioritize Recommendations – Focus Area 1**

Workgroup members presented and prioritized consolidated recommendations for Focus Area 1: *Modifications needed for current teaching performance assessments*.

**Emily Jimenez/Kalie Espinoza/Shiela Fernandez, Sweetwater Union High School District**, submitted a written comment which raised questions and concerns regarding the possibility of moving the timeframe of the TPA from teacher preparation programs to induction programs.

**Tristen Gartell, Santa Monica-Malibu Unified School District**, submitted a written comment which raised concerns regarding moving the TPA into induction and suggested the workgroup continue examining the shifts within the TPA process within its original context.

**5A: Develop Consolidated Recommendations – Focus Area 2**

Workgroup members reviewed recommendations for Focus Area 2: *Embedding performance assessments into coursework and clinical practice* to avoid duplicative work and drafted consolidated recommendations in small groups.

**Keri Morgan, San Diego County Office of Education**, spoke about the suggestion of the TPA going to three cycles versus the two cycles and the idea of local scoring.

**Therese Sorey, University of California, Irvine**, submitted a written comment regarding the unnecessary barriers of the edTPA.

**Andrea Reuter, California Teachers Association**, submitted a written comment which shared a story about Juan Carlos, a student teacher, struggling to fulfill the edTPA requirement and suggested the workgroup make a decision to eliminate the TPA as a credentialing tool in California.

**2B: Focus Area 3 Presentation and Panel**

Erin Sullivan, Acting Director, Cheryl Hickey, Administrator, Miranda Gutierrez, Interim Administrator, Karen Sacramento, Consultant, and Phi Phi Lau, Research Data Specialist, Professional Services Division, presented information about the accreditation process for preliminary and clear education preparation programs, emphasizing the role of performance assessments and provided an overview of the induction process.

**Guadalupe Cardona, California State University, Northridge**, spoke on this item which raised concerns regarding the TPAs.
