Division of Professional Practices Workload Report

Introduction

Updates on the Commission's Division of Professional Practices (DPP) workload is presented to the Commission to provide insight into the scope and level of work in educator discipline. This report covers the period of December 2024 through February 2025.

Background

The Commission's dashboards report on six key measurements in line-graph form, showing both current year numbers as well as prior year numbers for comparison purposes.

The "Total Cases" are the number of open cases within DPP, including cases in the Intake Unit, before the Committee of Credentials (Committee), pending before the Commission, and pending an administrative hearing. At the end of February, DPPs caseload was at 3,311.

"Cases Opened" are new cases opened during the month, from all sources, including criminal arrest notices, district reports, affidavits, and educators who self-report misconduct. In February, DPP opened 495 cases.

The "Initial Review" and "Formal Review" charts reflect the number of cases reviewed by the Committee at its normal three-day meeting in December. This two-step review process is required by statute. There were 82 Initial Review cases prepared in February. DPP continues to expect this number to fluctuate as cases move through the Committee process.







"Cases Closed" is the number of matters closed by Commission action, Committee action or closed by staff where the Commission has given formal delegation of authority (i.e., single alcohol offenses that do not involve schools, minors, or publicity). In February, 325 cases were closed.

"AG Cases" refers to cases in which an educator requests an administrative hearing to challenge the recommendation for discipline made by the Committee. An administrative hearing is an evidentiary proceeding where an administrative law judge hears and rules on the evidence. The Commission is represented in these hearings by the Office of the Attorney General (AG). The number of cases where the AG is representing the Commission is shown in the last graph. The number of cases currently at the administrative hearing stage is 174.

Next Steps

DPP is committed to work that is critical to public service and the Commission's mission. DPP continues to maintain a steady case production, while at the same time ensuring quality case preparation for the Committee.

Initial Institutional Approval – Stage V: Consideration of Institutional Approval for Alameda County Office of Education

Introduction

This agenda item presents, as part of Stage V of the Initial Institutional Approval (IIA) process, the report from the 2024 Provisional Site Visit for Alameda County Office of Education (ACOE) as well as the 2025 Revisit and the Committee on Accreditation’s recommended accreditation decision. The Commission granted Provisional Initial Institutional Approval to ACOE on [April 11, 2019](#). The Committee on Accreditation (COA) approved ACOE’s Designated Subjects: Career Technical Education on [February 21, 2020](#), and its Clear Administrative Services programs on [October 29, 2020](#). Consistent with the Commission's Initial Institutional Approval process, ACOE then began operating these programs and hosted a provisional site visit in December 2023. As a result of that provisional site visit, the COA placed stipulations on ACOE and, consistent with the IIA policy adopted by the Commission, a revisit was conducted in 2025 that resulted in COA removing all stipulations and moving the institution forward to the Commission for consideration of initial institutional approval.

Background

California law authorizes the Commission to accredit institutions to offer programs that lead to a credential to serve as an educator in California’s public schools. Among other responsibilities, Education Code section 44372(c) sets forth the Commission’s responsibility to rule on the eligibility of an applicant for initial accreditation for the purpose of offering a program of educator preparation.

The Commission requires that an institution seeking to offer new educator preparation program(s) must first be approved for initial accreditation as a new program sponsor and must do so by completing the Commission’s IIA process. The table below detailing the five stages of the IIA process.

The Provisional Site Visit was conducted in accordance with the procedures approved by the Commission and the Committee on Accreditation (COA) and outlined in the *Accreditation Handbook*. ACOE submitted a complete Program Review submission, Common Standards Review submission, and responses to preconditions within the year preceding its Provisional Site Visit. The Board of Institutional Review members assigned to the site visit worked together to review all evidence submitted as part of Program Review and Common Standards Review and provided feedback to ACOE regarding its preliminary alignment to the Commission’s adopted standards. Staff assigned to the Provisional Site Visit reviewed the institution’s responses to preconditions to ensure full alignment. In December 2023 the institution hosted its Provisional Site Visit and the results of the visit, including the team’s findings and accreditation recommendation, are available by clicking the link in the table above (*Report of Provisional Site Visit to Committee on Accreditation*, January 25, 2024).

The team determined that of the Common Standards, standards 2 and 5 were met, standards 1 and 3 were met with concerns, and standard 4 was **not met**; three program standards were met and two program standards were met with concerns for the Clear Administrative Services program; and eight program standards were met, six program standards were met with concerns, and two program standards were **not met** for the Designated Subjects: Career Technical Education program. As a result, the COA acted to place stipulations on ACOE and grant the status of Accreditation with Major Stipulations. In keeping with the Commission policy to allow an institution in provisional status to continue to work with the COA to address stipulations before coming back to the Commission for consideration for the last step in Initial

Institutional Approval, the COA determined that ACOE would remain in provisional status and be required to host a revisit within one year. The COA further required ACOE to submit quarterly progress reports to the COA to ensure that appropriate action was taken to address all stipulations

In accordance with the Commission adopted policy for Initial Institutional Approval, Commission consultants worked with ACOE to ensure that issues were being addressed and quarterly progress reports provided to the COA on the progress made by ACOE in addressing the stipulations. These quarterly reports were presented at the [May 2024](#), [August 2024](#), and [October 2024](#) COA meetings.

In January 2025, ACOE hosted a revisit focused on determining whether ACOE had addressed all stipulations. Upon conclusion of the revisit, the 2025 revisit team determined that all stipulations had been addressed, and all standards were now met. A report of the revisit team was presented to the COA in [February 2025](#) during which time, the team lead elaborated on the significant amount of progress ACOE had made in the year leading up to the revisit in addressing the stipulations. The COA acted to remove all stipulations and change ACOE's accreditation status from **Accreditation with Major Stipulations** to **Accreditation** and to forward the institution to the Commission for consideration for the final step in the Initial Institutional Approval process.

Staff Recommendation

Staff recommends that the Commission grant full initial institutional approval to Alameda County Office of Education.

Next Steps

If the Commission grants full initial institutional approval, the Administrator of Accreditation will assign the institution to one of the seven established accreditation cohorts and the institution will participate in all activities of the seven-year accreditation cycle established by the Commission.

Literacy Performance Assessment: edTPA Field Test Participant Waiver Requests

Introduction

This consent item presents requests that the Commission waive the reading instruction competence requirement (RICA) and the TPA requirement for candidates who successfully complete the edTPA Literacy Performance Assessment (LPA) and meet the passing standard for the edTPA LPA field test set by the Commission. This item recommends that the Commission approve the requested waivers for selected institutions for candidates that meet the adopted passing standard from Item 3C at the [December 2024 Commission Meeting](#). These waiver requests are in addition to the requests approved at the December 2024 and February 2025 Commission meetings.

Staff Recommendation

CalTPA PK-3 Early Childhood Education Mathematics Cycle Performance Assessment: Extended Field Test Participant Waiver Requests

Introduction

This consent item presents criteria for additional candidates identified for the CalTPA PK-3 Early Childhood Education (PK-3 ECE) Math Cycle field test and requests that the Commission waive the current CalTPA Cycle 1 requirement, for candidates who successfully complete the CalTPA PK-3 Math Cycle Performance Assessment and meet the field test expected performance level set by the Commission. This item recommends that the Commission approve the requested waivers for the PK-3 ECE candidates that meet the adopted passing standard of 14 points from [Item 5D](#) at the August 2024 Commission Meeting.

Background on the Teaching Performance Assessment Requirement

[Education Code §44320.2](#) requires all candidates for a Preliminary Multiple or Single Subject Teaching credential to pass an assessment of their teaching performance as part of the requirements for earning a preliminary teaching credential. Currently there are three Commission approved Teaching Performance Assessment (TPA) models for Multiple Subject candidates: CalTPA, edTPA, and FAST. Commission staff are developing a PK-3 version of the CalTPA based on the newly adopted PK-3 ECE teaching performance expectations (TPEs).

The Commission's CalTPA model has been approved for use in California since 2008. Cycle 1: Learning about Students and Planning Instruction is currently being revised and has been retitled to CalTPA PK-3 Math Cycle Performance Assessment: Learning about Children and Planning a Math Activity. New math cycle assessment tasks and scoring rubrics have been developed to assess the PK-3 ECE Teaching Performance Expectations (Domains 1 through 8) specifically the new TPE Domain 8: Effective Mathematics Instruction in a PK-3 setting, with input from the PK-3 Math Cycle Performance Assessment Workgroup found in [Appendix A](#).

Approved PK-3 Programs to Participate in the Field Test

The field test of the CalTPA Math Cycle will provide an opportunity to collect data about the teaching performance of candidates from two recently approved PK-3 ECE programs: Riverside County Office of Education (RCOE), a local education agency (LEA) Intern program and Vanguard University, a traditional student teaching pathway.

Institutions in Table 1 meet the following participation criteria:

1. The institution is in good standing with the Commission and has been approved to offer a preliminary PK-3 ECE teacher preparation program.
2. The institution agrees to fully participate in the CalTPA PK-3 Math Cycle field test, which requires:

- a. Working with Evaluation Systems (ES) and Commission staff to select a diverse group of candidates by December 2024 to field test the CalTPA PK-3 Math Cycle;
- b. Providing the expected level of support for field test participants defined in program standard 6 with the additional focus on TPE Domain 8 elements measured by the CalTPA PK-3 Math Cycle;
- c. Ensuring that all field test participants have a fair and equitable opportunity to complete the CalTPA PK-3 Math Cycle and submit scoreable evidence to ES by December 2024; and
- d. Providing field test participants who do not meet the expected performance level on the CalTPA PK-3 Math Cycle with remedial support and the opportunity to resubmit the Math Cycle in January 2025.

Once waivers are approved for the two programs’ candidates, Commission staff will communicate to programs and begin providing online support to prepare faculty and cooperating teachers for the fall administration of the CalTPA PK-3 Math Cycle field test.

Programs Recommended for Literacy Certification in Accordance with SB 488 (Chap. 678, Stats. 2021)

Introduction

This agenda item presents for Commission action programs that have successfully completed the review process established by the Commission for literacy certification pursuant to SB 488 (Chap. 678, Stats. 2021).

Background

SB 488 made several changes to the Education Code that required that the Commission revise and update the teacher preparation program standards for literacy instruction, develop a literacy performance assessment that would replace the Reading Instruction Competence Assessment beginning July 1, 2025, and certify that all Multiple Subject and Education Specialist teacher preparation programs be certified that they adhere to Education Code section 44259 (b)(4)(A) and (B), including the following:

*Study of effective means of teaching literacy, including, but not limited to, the study of reading as described in subparagraphs (A) and (B), and **evidence-based** means of teaching foundational reading skills in **print concepts, phonological awareness, phonics and word recognition, and fluency** to all pupils, including **tiered supports** for pupils with reading difficulties, English learners, and pupils with exceptional needs. The study of effective means of teaching literacy shall be in accordance with the commission's standards of program quality and effectiveness and current teaching performance expectations, shall be aligned to the current **English Language Arts/English Language Development (ELA/ELD) Framework** adopted by the state board, and shall incorporate the program **guidelines for dyslexia** developed pursuant to Section 56335. The study of reading shall meet the following requirements:*

- (i) The study of organized, systematic, explicit instruction skills including phonemic awareness, direct systematic, explicit phonics, and decoding skills.
- (ii) A strong literature, language, and comprehension component with a balance of oral and written language.
- (iii) Ongoing diagnostic techniques that inform teaching and assessment.
- (iv) Early intervention techniques
- (v) Guided practice in a clinical setting

In December 2024, the Commission approved a process for certifying Multiple Subject and Education Specialist teacher preparation programs, as required by statute. That agenda item is presented here: [December 2024 Commission Agenda Item](#). This process included a review of each program by a team of two or more external literacy educators to ensure that the program complies with the requirements of Education Code section 44259(b)(4)(A) and (B). The submission requirements for institutions were based upon those aspects of Program Standard 7 and Teaching Performance Expectation (TPE) 7 as they relate specifically to Education Code

section 44259 (b)(4)(A) and (B). For more information on this detailed process, please see the December 2024 Commission agenda linked above.

Programs Recommended for Literacy Certification

Education Code section 44320.3 (b) requires that

*Before requiring successful passage of the teaching performance assessment for the preliminary multiple subject teaching credential and the preliminary education specialist credential pursuant to subdivision (a), **the commission shall certify** that all of the teacher education programs approved by the commission pursuant to Section 44227 provide instruction in the knowledge, skills, and abilities required in subparagraphs (A) and (B) of paragraph (4) of subdivision (b) of Section 44259.*

The programs and pathways in the table below have been reviewed by a team of reviewers in accordance with the processes outlined in the December 2024 agenda item and have been determined to meet all aspects of Education Code section 44259(b)(A) and (B). These programs are being recommended for certification by the Commission as prescribed by Education Code section 44320.3 above. Included below are the name of the institution, the specific credential program, the types of pathways in which the program is offered – all of which have been reviewed – and the URL where the documents may be accessed, as well as any passwords or access codes that may be needed. If no password or access code is listed, none is needed.
